MeSince Technology Limited is not a CA, MeSince APP install the Account Certificate (one encryption certificate and one V1 identity certificate) automatically that MeSince APP apply those certificates from WoTrus CA system. MeSince name Root CA and related issuing CA are hosted and maintained by its parent company – WoTrus CA Limited, A licensed CA in China.

4. MeSince AIA, CRL and OCSP

MeSince AIA/CRL/OCSP system is hosted and maintained by WoTrus CA, but it uses its own domain as: aia.mesince.com, crl.mesince.com, ocsp.mesince.com.

To let MeSince APP fast process the certificate status in mobile APP, WoTrus provides Cloud Certificate Status Protocol (CCSP) for MeSince APP, an OCSP cloud service designed for MeSince.

5. MeSince Time Stamping Service

MeSince timestamp every outgoing email automatically, this RFC 3161 time stamping service is hosted and maintained by WoTrus CA, but it uses its own domain: tsa.mesince.com.

6. MeSince Certificate Revocation

MeSince users can apply certificate revocation in MeSince website, it will be processed by WoTrus CA system and WoTrus Staff according to WoTrus CPS.

7. MeSince Certificates Fees

MeSince default Account Certificate is **free** for all MeSince APP users including one encryption certificate and one V1 identity certificate.

MeSince also provide charged authentication service: Individual Validation and Organization Validation, its service fees are detailed on the official MeSince website (www.mesince.com). The Individual Validation and Organization Validation process is operated by WoTrus staff based on WoTrus CPS.

8. MeSince Subscriber Agreement

MeSince users shall comply with the Subscriber Agreement listed in WoTrus CPS 9.6.3.
